ORDINANCE NO. 24491

AN ORDINANCE AMENDING THE NUISANCE CODE, TITLE 24 **TULSA** REVISED ORDINANCES ("TRO"), SECTION 101. "NUISANCES AFFECTING HEALTH", SUB-SECTION "B", BY THE ADDITION OF NEW NUMBERED PARAGRAPHS, PARAGRAPH 19, CONCERNING FACE COVERINGS, SOCIAL DISTANCING. SEPARATION, AND OTHER MANDATES IN TITLE 27, ORDINANCES NOS. 24408 AND 24490, AND CONCERNING ENFORCEMENT THEREOF, AND PARAGRAPH 20, CONCERNING EVENTS OR GATHERINGS EXCEEDING THE NUMBER OF PERSONS SPECIFIED IN ORDINANCE 24490, SECTION 412, AND CONCERNING ENFORCEMENT THEREOF, AND PARAGRAPH 21 PROVIDING FOR EXPIRATION DATE; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

## BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That Title 24, Tulsa Revised Ordinances, "Nuisances," Section 101, "Nuisances Affecting Health", sub-section B, "Health Nuisances," be amended by the addition of new numbered paragraphs, Paragraph 19, Paragraph 20, and Paragraph 21 as follows:

- **"19.** Any Place of Public Accommodation, Public Setting, or Educational Institution as defined in Title 27 Ordinances No. 24408, that has not made efforts to comply with the defined measures prescribed in Title 27 Ordinances Nos. 24408, 24490 and amendments thereto including face covering, social distancing, separation, event or gathering requirements, or other mandates. This paragraph may be enforced by Tulsa Police Department, the Nuisance Enforcement Official as provided in Sections 201 or 204, below, and the Director of Health and persons acting under his or her orders, as provided in Sections 201 or 204, herein, and Sections 104, 105 and 106 of Title 17 TRO, 'Health Regulations.'
- **20.** Any event or gathering held on or after December 11, 2020, that exceeds the number of attendees set forth in Ordinance No. 24490, Section 412, at which the organizers, or other persons or entities responsible for conducting, producing or hosting such event or gathering have failed to obtain, or which is not in compliance with, the requirements of the COVID-19 safety plan approved by the Tulsa Health Department a minimum of fourteen (14) calendar days prior to the event or gathering as required in Title 27 Ordinance No. 24490, Section 412. This paragraph may be enforced by Tulsa Police Department, the Nuisance Enforcement Official as provided in Sections 201 or 204, below, and the Director of Health and persons acting under his or her orders, as provided in Sections 201 or 204, herein, and Sections 104, 105 and 106 of Title 17 TRO, 'Health Regulations.'

21. That the above Paragraphs 19 and 20 shall remain in force and effect only so long as Title 27 Ordinances Nos. 24408 and 24490, as amended, remain in effect."

Section 2. That if any part or portion of this ordinance is held to be unenforceable by a court of competent jurisdiction, such holding shall not affect the remainder of the ordinance.

Section 3. That all ordinances of the City of Tulsa in conflict herewith are hereby repealed.

Section 4. Emergency Clause. That an emergency is now declared to exist for the preservation of the public peace, health and safety, by reason whereof this Ordinance shall take effect immediately from and after its adoption and required approvals.
