

## **CLASS TITLE: STREETS & STORMWATER OPERATOR II**

**PURPOSE OF THE CLASSIFICATION:** Under general supervision is responsible for performing a variety of semiskilled tasks while working as a member of a crew engaged in general maintenance or operation activities involving City services or facilities, and other related assigned duties.

### **ESSENTIAL TASKS (All Divisions):**

- Repairs and maintains storm sewer and/or streets system
- Prepares site protection devices and maintains worksite safety and other records and forms
- Installs and removes shoring equipment
- Responds to emergencies such as storm clean up, flooding, and ice and snow control
- Performs normal adjustment, service, and routine maintenance on equipment
- Loads and delivers equipment and work materials
- Operates a variety of powered and heavy automotive equipment which could include tandem axle trucks, dump trucks, winch trucks, small rollers, batwing mowers, loaders, bobcat/skid loaders, backhoes, water trucks, pavement breakers, and tractors with box blade
- Cleans up work area and equipment when job is completed
- Occasionally directs the work of a Streets & Stormwater Operator I or fills in for an Operator IV as needed
- Must report to work on a regular and timely basis

**In addition to the above tasks, the following essential tasks may be required by the individual division.**

### **Stormwater**

- Maintains pesticide application records
- Monitors and maintains grounds and irrigation
- Maintains, cleans, and repairs creeks, various facilities, irrigation systems, surface drainage lines, and ditches
- Removes trash/debris and brush from various facilities
- Performs flood prevention and erosion control duties
- Builds, installs, and repairs gabion retaining walls, driveway and crossover tiles, fences, and concrete pipe
- Sprays pesticides, herbicides, and waters landscape areas.
- Maintains, trims, and removes plants and trees

### **Street Maintenance**

- Maintains and repairs streets and curb/gutter with a crew
- Establishes elevation and sets forms for concrete
- Performs concrete and asphalt finishing
- Understands speed hump installation
- Sets up traffic control and flags traffic
- May assist with graffiti removal

**Reasonable accommodations may be made to enable individuals with disabilities to perform the essential tasks.**

### **QUALIFICATIONS:**

**Training and Experience:** Graduation from high school or possession of a General Educational Development (GED) Diploma, and one (1) year of experience as a Streets and Stormwater Operator I; or completion of tenth (10<sup>th</sup>) grade and three (3) years' experience in heavy manual labor; or an equivalent combination of training and experience per Personnel Policies and Procedures, Section 128. Refer to the

Streets and Stormwater Operators Progression criterion document for additional requirements. Must be able to pass a basic reading/writing aptitude test.

Knowledge, Abilities, and Skills: Good knowledge of basic manual labor practices, methods, tools, and materials of heavy construction work; and good knowledge of the hazards and safety precautions of the work. Ability to follow verbal instructions and read and follow written instructions; ability to perform manual labor for an extended period of time in varying weather conditions; ability to operate various types of automotive and other power equipment; ability to operate computers; and the ability to courteously and tactfully communicate with fellow workers, supervisors, other members of the organization, and the public in giving and receiving information.

Physical Requirements: Physical requirements include frequent walking and standing; occasional lifts/carries up to 105 pounds; frequent lifts/carries up to eighty (80) pounds; frequent pushing/pulling up to 60 pounds; frequent reaching, balancing, bending, kneeling, handling, climbing, smelling, and twisting; occasional crawling and feeling; and vision, speech, and hearing sufficient to perform the essential tasks.

Licenses and Certificates: Possession of a valid Oklahoma Class "A" Commercial Driver's License with applicable endorsements; some positions may require an Oklahoma Department of Agriculture Pesticide Applicator certification for Service Technician in either/both the Ornamental Turf Category and Right of Way Category and/or an appropriate technical license within nine (9) months of date to hire (in some positions).

**WORKING ENVIRONMENT:** Working environment is primarily outdoors and, and in inclement weather. May be exposed to the following: hazardous materials, animal waste/dead animals, flammable liquids, radiation, traffic, cramped work areas, excessive dust, weather/temperature extremes, trench excavations, underground gas/electric/petroleum lines, rough terrains, cutting/chipping/grinding, hazardous/toxic atmospheres, sewage, damp/wet surfaces, snow/ice covered surfaces, animal bites, snake bites, insect bites, poisonous plants, overhead power lines, toxic fumes/vapors/odors, confined spaces, compressed gases, high noise areas, oily surfaces, refuse/garbage/litter, and required to work overtime and be on 24 hour standby.
