**PURPOSE OF THE CLASSIFICATION:** Under general direction provides technical, analytical, and investigative assistance to police personnel to aid in the identification, investigation, and arrest of criminal offenders and conspirators; and performs other related duties as assigned.

**ESSENTIAL TASKS:**

- Studies current literature on research methodology and policing issues and provides appropriate recommendations for improvements in crime analysis practices
- Recommends professional training courses for the crime analysts for continuing education
- Trains personnel in division procedures, functions and processes
- Creates, builds, and maintains queries in Computer Aided Dispatch systems and dashboard in data visualization applications
- Creates strategic and administrative reports for various users
- Researches complex crime trends and patterns developing criminal profiles for offenders
- Attends regional meetings of law enforcement personnel to provide information on crime series, patterns, and methodologies
- Attends meetings with members of the TPD, criminal justice agencies and the State Intelligence Fusion Center to obtain or disseminate information
- Creates written and verbal presentations, using charts and graphs to inform internal customers of emerging or existing crime series, patterns and trends to develop suspect profiles
- May be require to testify in court
- Reports to work on a regular and timely basis
