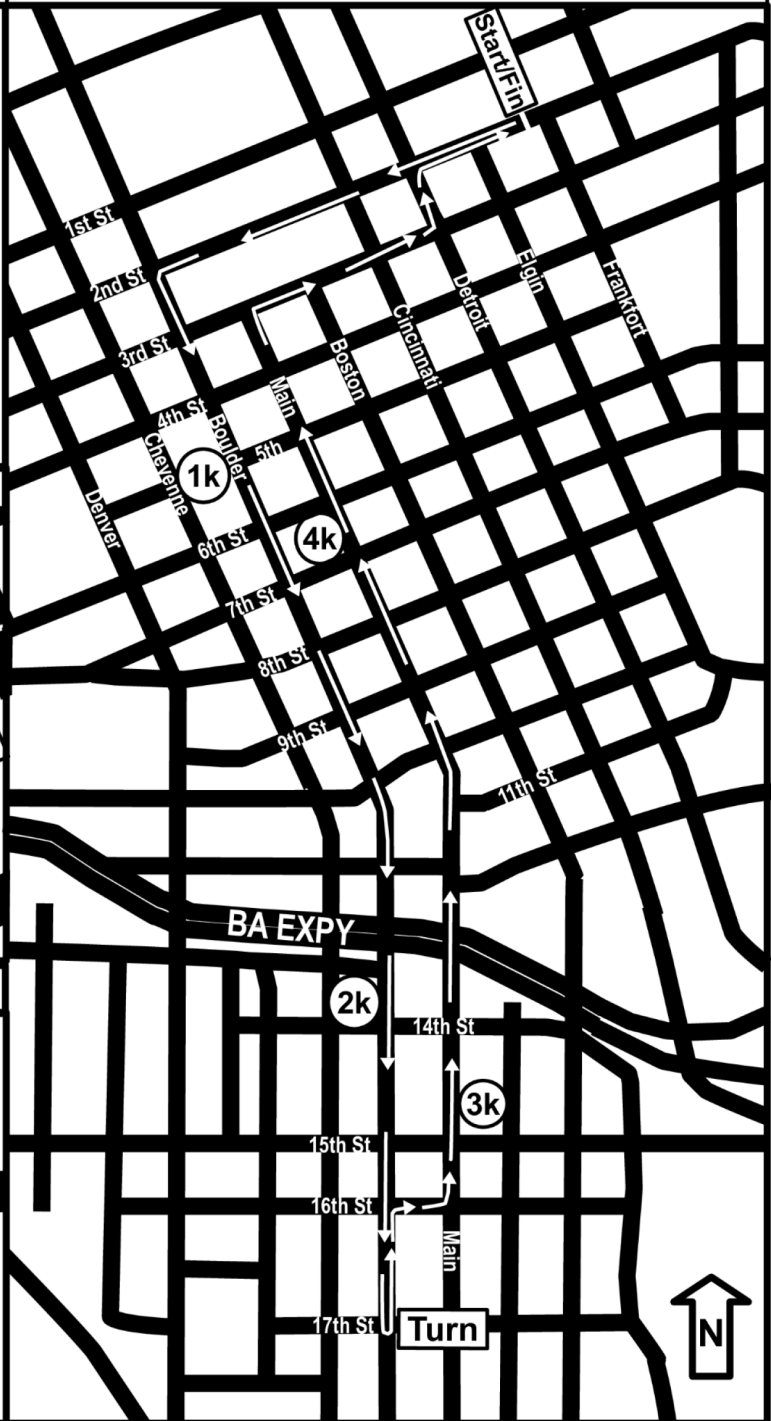

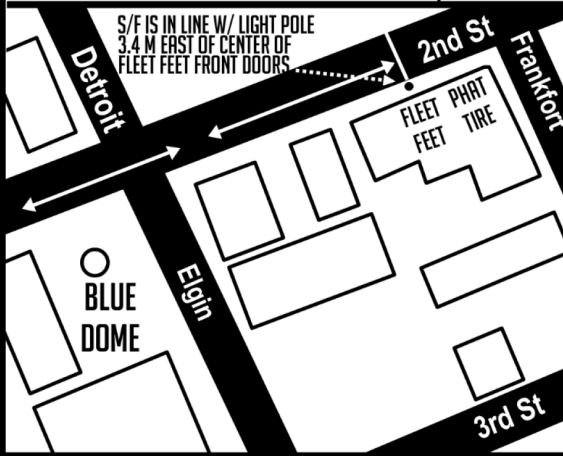
Turnaround: On Boulder, 0.4 m S of the yellow fire hydrant on the SE corner of 17th & Boulder.

3k: On Main St, 8 meters north of the parking garage entrance at Boulder Towers. (GPS 36.141543 -95.987382)

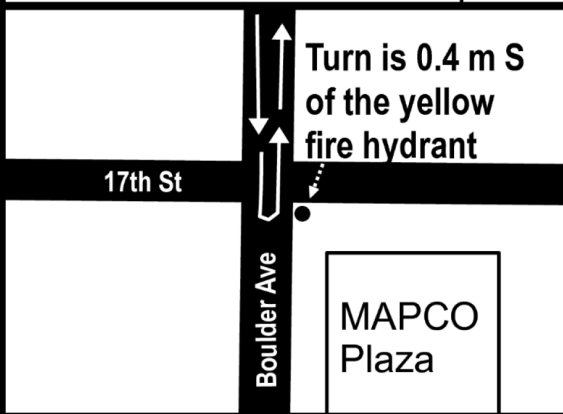
4k: On Main St, 12.8 m N of the center of the front doors of One Main Plaza, just S of 6th & Main. (GPS 36.150235 -95.989368)
