CPR/AED/First Aid Non-Certification

Learn new skills or refresh and update your old skills in cardiopulmonary resuscitation and automatic external defibrillator. This class teaches the same materials and skills as the certification class and includes lectures, hands-on, and discussion with some videos. We will schedule special non-certification CPR/AED/First Aid classes for groups of seven-to-10 people. There is no cost to your department for non-certification courses. This class is designed for new employees assigned to perform permit-required confined space entry duties or for employees who haven't performed permit-required confined space entry but are now expected to do so. **This is not a refresher course.** Practical, hands-on training must be completed in conjunction with each employee's work group.

HAZWOPER – 40-Hour Certification

This training class will provide basic health and safety skills for employees working with and around hazardous materials and waste. The course offers the 40-hour safety training requirements mandated by OSHA 29 CFR 1910.120. It also includes OSHA regulations, identifying hazardous materials in the workplace, limiting hazardous



exposure with PPE, establishing site plans, and understanding the use of SDSs. Students completing this class will receive a 40-hour HAZWOPER certification card. *Departments must pay for their employees to attend this training*. Contact **Safety@cityoftulsa.org** for more information.

HAZWOPER – 8-Hour Refresher for 40-Hour Certification Renewal

OSHA General Industry – 10 Hour

Smith System Driver Training

The City of Tulsa has adopted the Smith System for non-sworn driver training. This course combines classroom and behind-the-wheel training to equip your drivers with the knowledge and skills to reduce crashes, lower costs, and save lives regardless of the vehicle the employee drives. The class consists of two hours of classroom instruction and six hours of driving. Students will perform several driving demonstrations while assessing other students' use of the Smith 5 Keys.

Traffic Control (MUTCD) Training

and signs are used correctly in temporary traffic control situations, including flagging procedures. It will also address the MUTCD Typical Applications and the development of Traffic Control Plans.


