PURPOSE OF THE CLASSIFICATION: Under general supervision is responsible for administering summer day camp programs to patrons; and performs other related assigned duties.

ESSENTIAL TASKS:

- Supervises day camp patrons, under the direction of Parks staff
- Programs and implements continuous enrichment activities daily and accompanies camp patrons on off-site field trips
- Maintains discipline, order, and safety for day camp and park patrons
- Reports any concerns or problems immediately to Parks staff
- Interprets recreation programs and enforces City of Tulsa policies and procedures with day camp and park patrons
- Maintains current and accurate records pertaining to day camp and camp patrons
- Assists in maintain parks facilities and reports any needed repairs or concerns to Parks staff
- Reports to work on a regular and timely basis

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential tasks.

QUALIFICATIONS:

<u>Training and Experience:</u> Must meet the following criteria:

- (a) Must be at least 17 years old at the time of employment; and,
- (b) Experience in supervising and leading elementary and middle school age children in age-appropriate activities *preferred*
