**APPOINTMENT OF DEPUTY CITY TREASURER  
OF THE CITY OF TULSA, OKLAHOMA**

By the virtue of the power vested in me as Mayor of the City of Tulsa, it is hereby ordered:


Section 1. **Purpose.** This Executive Order is issued pursuant to Article III, Section 1.4F and Article III, Section 3 of the amended Charter of the City of Tulsa, Oklahoma for the purpose of making a personal appointment to fill the Office of Deputy City Treasurer.

Section 2. **Appointment.** That Chad Becker of the Finance Department be and hereby is appointed as Deputy City Treasurer of the City of Tulsa, Oklahoma, and as such said appointee shall have the power to:


- A. Deposit and maintain the funds of the city in depositories approved by the Council;
- B. Invest the funds of the city; and
- C. Perform such other duties as assigned by the Mayor or as prescribed by this amended Charter, by ordinance, or by the laws of Oklahoma.


Section 3. **Effective date.** This Order shall take effect immediately.
